

# PASTORAL TITLE

The elders have approved a pastoral title change and bring it forward to the congregation for consideration and vote. A vote by the congregation is necessary to grant Paul Spilker the title of Lead Executive Pastor. Our bylaws dictate that the title of "pastor" is granted by the congregation, and the position of assistant pastor is granted by the elders.

### Lead Executive Pastor

The elders of College Park have approved the pastoral title for Paul Spilker of "Lead Executive Pastor" and present it for congregational consideration and vote at the Congregational Meeting on Sunday, May 19.

Paul is currently serving as the Executive Director of Ministries & Operations. With the pastoral title change, he will continue in the same duties. Paul is pursuing ordination-to be completed within two years of this vote.

In this role, Paul serves as chief of staff, facilitating the Directional Team, leads the implementation of the ministry vision for College Park Church (North Indy) with other staff and elders, and coordinates the alignment of church ministries and operations.

# **BYLAW UPDATES**

The last revision to our Code of Bylaws was November 2017. In an effort to make sure our bylaws are upto-date with our current operations, the church bylaws are regularly updated. A team of staff members and elders reviewed the bylaws and recommend any needed changes, resulting in the following recommendations:

- 1) The majority of the revisions that are recommended pertain to grammatical errors and typos.
- 2) Article VI Finances, Section 2 Disbursements: there is an error which states "less" than \$25,000 instead of "more" than \$25,000.
- 3) Article IV Membership, Section 5 Exclusion: this change was made to clarify that the elders have the power to remove individuals in good standing from membership, including those who have not attended for six months are presumed to have requested exclusion. In accordance with Matthew 18:15-20, the authority to remove members for the purpose of church discipline remains with the congregation.

All bylaw changes are approvd by the elders and the congregation.

#### ARTICLE VI - FINANCES, SECTION 2 - DISBURSEMENTS

"Items requiring expenditures less more than twenty-five thousand dollars (\$25,000) not covered by the Financial Budget shall be approved by a majority vote of the Elders present at a duly called meeting."

#### ARTICLE IV - MEMBERSHIP, SECTION 5 - EXCLUSION

"Exclusion from membership shall be effective only upon a majority vote by the Elder Council at a regular or special meeting pursuant to these Bylaws. Members who do not attend the regular services of the Church for a period of six months shall be presumed to have requested excluded sion for themselves from membership in the Church, unless otherwise determined by the Elders or their designees. Exceptions to this rule shall apply in cases of illness or infirmity, missionary and Christian service, absence due to military service and temporary employment not involving a permanent relocation. The names of members who have been requested excluded sion will be under the oversight of the Eelders to see if other appropriate actions needs to be taken. Members who have requested or who are presumed to have requested exclusion may be removed from membership upon a majority vote of the elders in a regular or duly called special meeting of the Elder Council pursuant to these Bylaws."
